3. No contract shall exist until a signed booking form and a **deposit of £100 per week** has been received. Telephone reservations will be held for seven days pending receipt of booking form and payment of deposit.
4. The full balance for accommodation is payable no later than 30 days before arrival.
5. All payments must be made in Sterling with a cheque drawn on a British Bank and made payable to: Mrs P Brookes.
6. Lettings, unless otherwise agreed, are on a weekly basis and commence from 2 p.m. on the day of arrival to 10 a.m. on the day of departure. If departure is delayed, the owner reserves the right to re-enter the property.
